COOK stated at 0900 hrs on 24 SEP 15 she received a voice mail from MORROW, Lakisha and called MORROW, Lakisha back at 1350 hrs on 24 SEP 15. COOK stated MORROW, Lakisha asked if COOK was going to give her daughter MORROW, Alicia back to her. COOK stated she told MORROW, Lakisha that she wasn't going to give her back to her and MORROW threatened to beat her up and said it's not a threat, it's a promise and that she has a guy watching her every move. COOK stated she believes the guy watching her and giving MORROW, Lakisha information is acquaintance BROWN, Darius. COOK stated she has the call recorded as well as a call on 19 AUG 15 where MORROW said she was going to call the police and file kidnapping charges against COOK. COOK stated in December 2014 MORROW, Lakisha and COOK signed a notarized letter which stated MORROW, Lakisha wanted COOK to care for and later adopt her daughter MORROW, Alicia. COOK stated she has seen MORROW, Lakisha twice since she and MORROW, Lakisha signed the document. COOK stated she filed for benefits with DHHS and had to tell them MORROW, Alicia was living with her. COOK stated DHHS now wants MORROW, Lakisha to pay back the amount of benefits she received for MORROW, Alicia while she was not in her care. COOK stated she believes this is why MORROW, Lakisha is mad at her.
