The complaint and affidavit of Officer Jeffrey KOZENY #1662, on this 4th day of February, 2016, who, being first duly sworn, upon oath says:

That the officer has just and reasonable grounds to believe, and does believe that there is concealed or kept as hereinafter described, the following property, to wit:

On Tuesday, 12 January 2016 at 1107 hours, Officer Robert SEITZER #2207 and Officer Ann VOS #1415 were dispatched to ██████████ to investigate a Sexual Assault. Upon arrival, Officer SEITZER and VOS spoke with ██████████. ██████████ stated that her daughter, ██████████ (2 years old) attends the Little Hands at Work and Play Daycare, 1714 N. 120 St., Omaha, Douglas County, Nebraska. ██████████ received a call from ██████████ a daycare worker, who reported suspicious activity that happened in the daycare bathroom between her daughter and employee, Mark MAYS. Officer VOS and SEITZER spoke to daycare employee, ██████████.

██████████ who stated that she entered the bathroom and saw ██████████ sitting on Mark MAY'S lap, straddling and facing him. ██████████ was naked from the waist down and she was talking to Mark MAY'S. Mark MAY'S was fully clothed and could not see where his hands were. ██████████ stated that Mark MAY'S should not have been in the bathroom with ██████████ because she is fully potty trained. After ██████████ witnessed this incident, she walked out of the bathroom and had ██████████ another daycare employee, go in to verify what she saw. Officer VOS and SEITZER did not talk to ██████████ at the time of the original report, because she was not working at the time.

██████████ stated that ██████████ wears underwear and they should have been on. ██████████ did not notice any injuries while bathing her daughter. Mark MAY'S was fired from the daycare.

On THU 04 FEB 16 at 0904 hours, R/O KOZENY # 1662 had scheduled a meeting with Mark MAY'S to speak to him about the incident listed on the information report. R/O drove him from his address, ██████████ without handcuffs to OPD Central HQ to complete the interview. He was advised of his Miranda Rights and he agreed to talk to R/O. He advised that with the first victim, ██████████ he had undressed her completely and sat her on his lap, facing him. He stated prior to the witnesses, ██████████ and ██████████ he has placed his pinky finger inside of her vagina. He showed R/O by placing his left pinky finger into a hole he made with his right hand. He stated the witnesses came in after that. He was asked what he was thinking at that time. He stated he would place the children on his lap so he could "get hard". He was asked what that meant. He stated he wanted to get an erection.

As the interview went on, he admitted to placing his ring finger inside of another girl at Little Hands at Work and Play named ██████████. He was asked about further incidents in the past. He gave 6 other names, and the names of the daycares they went to. Two girls went to Little Hands, and the others went to La Petite at 10707 Birch St. R/O will follow up with daycares to find out who the other victims are.

He was asked if he has ever looked at pornography. He advised he had looked at porn on his home computer and his cellphone. He was asked about child pornography. He stated he has looked at child pornography on his apple cell phone. He agreed to give the phone to R/O and signed a permission to search form. A warrant will be completed to search the phone at a later time.

He advised approximately 6 years ago he had taken care of a child with down syndrome. He stated while the girl was going to the bathroom, he took pictures of the girl's underwear after she took it off. He advised he did not leave the pictures anywhere. He advised he still had the phone. He currently lives with his mom and dad.

He was booked for 2 counts of 1st degree sexual assault of a child, and 6 counts of 3rd degree sexual assault of a child.


